### 1. ENTRIES **\$10.00 ENTRY FEE** **PRIZES Heaviest fish \$500 and 5 x \$50 mystery weights**

Entry Tags can be picked up at Competition Headquarters tent on Thursday 26 Jan

**ENTRIES accepted to 12 noon Thursday 26 Jan, but MUST enter prior to fishing.**

### 2. COMPETITION TIMES **6.00am starts – 5.00pm closes (presentations at 5.15pm)**

### 3. WEIGH-IN **WEIGH-IN TENT NEXT TO BOAT RAMP from 12 noon to 5.00pm**

Competitors MUST weigh in their own fish & present their own tag, closing at 5.00pm sharp.

### 4. PRESENTATION **5.15pm Thursday 26 Jan 2012, adjacent to the Boat Ramp**

A BBQ will be available at reasonable cost from 12 noon. All Food and drinks on sale

### 5. RULES **All state laws must be adhered to – minimum length 27cms + bag limits**

**IN THE INTEREST OF FISH CONSERVATION, ONLY ONE (1) FISH WILL BE ACCEPTED FOR WEIGHIN in this competition, for BOTH the heaviest fish AND mystery weight prizes.**

- Fish must be weighed uncleaned, in the same condition as caught. No frozen or damaged fish** will be accepted. Competitors must weigh in their own fish and present their own tag. NO FISH will be accepted for any other competitor. Fish will be scrutinised before acceptance, & may be rejected if it does not meet this standard. Competitors who have fish rejected will have the "Right of Appeal" to the "Competition Appeals Tribunal."
- Fishing is restricted to Port Phillip Bay, and for Flathead ONLY, fishing from boat, pier, breakwater, jetty or shore. All State Fishing Laws, including licences, must be complied with.
- Adjudication on all matters incidental to the conduct of this competition shall be vested in the "Competition Committee" of Werribee South Fishing Club Inc, who may at anytime before or during the event reject or disqualify any entry at their discretion
- Right of Appeal.** All fish that are the subject of appeal must be retained by the Weighmaster. Failure to allow the fish to remain with the Weighmaster will invalidate any appeal, which must be lodged in writing with the "Competition Appeals Tribunal" when the fish is rejected AND prior to the competition closing time of 5.00pm on 26 January 2012. The Competition Appeals Tribunal will consist of three executive members of the Werribee South Fishing Club, who will convene when the protest is lodged. No correspondence will be entered into and the Tribunal's decision is final and binding,
- Prizes are awarded strictly to the winners and are not transferable.

### 6. FISHING PRIZES **One prize per entrant - Competitors Must present own Tag to receive Prizes**

Heaviest Fish weighed in first - \$500 cash & trophy, Five mystery weight prizes of \$50 cash each & trophy
